

# STEP 2


For every transaction when changing payment cards, you must create a new email and use that email for registration. Write down the password.

### STEP 3

Visit any NFT product within the auction page (for example <u>https://mobhfoundation.org/product/mobh-eternity-vip4-life-nft/</u>) and at the bottom you have the option to join the auction or better directly choose the BUY buttons with different values for direct payment link:



Click on any of the four BUY buttons and look again for the **Buy** button. Via this method you are also getting this domain together with the NFT for life which will showcase the artwork forever, i.e. an eternity equivalent to "forever online".





Once you click on second BUY you shall see something like the following (depending on your IP the currency might be different but it will be equivalent to cca 4000 US dollars):

You can click directly on the button "I am ready to pay" in order to proceed directly with the full bidding price at the auction. Choose the option "Continue with EMAIL" and then your contact that is going to make the payment shall enter an email (for every CARD register one new email, so every user must have its own email with different card) and type any password (which he must write down or remember for next steps in order to complete the process). Thus, please remember/save this new password that type as you will need it for the next step.



It is very important that you copy and save the link leading to this page and make a screenshot of the page with the link before you click COMPLETE TRANSFER and send it to <u>mobhnft@proton.me</u> and wait for our reply when to click Complete Transfer.

Our experts can do for you also steps 9, 10 and 11 but we would require your email passwords and the newly create password of the portal that you used for the payment.

After this process is completed successfully, save all the documents and print them as these are your proofs of ownership of this NFT website gallery.

From our experience, the new online site together with the NFT will take several days to transfer to your name and be operational. Then another several days the funds will transfer to our account as it has to be paid from the Auction payment gateway as classical WIRE TRANSFER. Thus, total amount of days estimated for the payments to clear is 15-25 days, sometimes more depending on the country and card. After this, our accounting department will justify the BIDDING FUNDS, pay taxes and all auction costs (including payment processing fees, etc.) and only then the process can be considered fully completed i.e. once the funds are cleared and on our accounts without any blockage. Legitimacy, clearing and origin of



funds is purely the responsibility of the potential bidder/client and MOBH or his afiliates are not in charge for this part of the process or due dilligence.
